 - b) **South Green:** The work at South Green has now been completed, the bench will be sited during the weekend of the 17^h December and the gates will be opened. The Clerk will organise advertising and posters to alert parishioners of the new facility for dog walking and recreation. Thanks were given to the Chairman for his work on this project.

The replacement toilets at Harleston are now to be relocated and the old block refurbished. Consideration is being given to the car park in Harleston, a group is to be formed to undertake negotiations with SNC on this matter.

Following the call for sites to meet housing needs for 2026-2036, 3 sites have been identified for consideration in PSM.

- ➤ To discuss request from NAR Council discussed a request from NAR, who provide paramedic services. Cllr Ellam proposed a donation of £200, this was seconded by Cllr Hudson and unanimously agreed. Cllr Burridge further proposed a match funding donation was provided to the Air Ambulance this was seconded by Cllr Richards and unanimously agreed.
- ➤ To consider draft budget for 17/18 The draft budget prepared by the Clerk was circulated, details of this year's tax base and funding will be circulated when received and the precept will be set at the January meeting.
