Minutes of the Parish Council Meeting held in the Pennoyer Centre, On Tuesday, 8th November 2016 at 7.30 pm.

Present: Cllrs Glover, Langshaw, Ellam, McDaniel, Richards and Cllr Burridge arrived during the meetina.

In Attendance: The Clerk and one member of the public were in attendance. K Worrell attended during the meeting in response to a request from the Clerk and to answer questions from Council on Xmas events being held in the village.

- 1: To consider accepting apologies for absence: Apologies were accepted from Cllr Albon, Cllr Clarke & District Cllr Hudson, who was attending a meeting on devolution and aimed to attend following this. County Cllr Wilby provided a copy of his report and gave apologies for the meeting
- 2:
- To consider declarations of Interest: no new declarations were received To approve minutes of the last meeting of 11th October 2016: The October minutes were 3. signed as correct

4: To discuss matters arising from the minutes of the last meeting – for information only:

- a) Parish Website: The monthly reports have been updated
- b) Streetlighting: This item was moved to items for consideration
- c) North & South Green: The scheduled work on fencing and security posts has been completed at North Green play area and South Green.
- 5: To receive the Chairman's Report: The Chairman thanked the volunteers who helped carry out the ground work at North Green playground, the area is currently fenced off to allow the grass to establish. The matting at the play area has been reported as slippery; this has now been scheduled to be cleaned within the next couple of weeks.

The new bench has arrived and will shortly be sited at South Green.

The Chairman updated Council on the recent theft of Lead from the Church. Council received this information with much regret.

6: To receive the County and District Councillor's Reports:

The County Cllr 's report will be posted on the parish website.

The Clerk will circulate information provided by the District Cllr from the Local Government Boundaries Commission and also on the current call for sites; these items will be moved to the December meeting if required.

7: **Public Forum**

The exposed cable on Poppys Lane was discussed, this has been reported to Highways and has now been marked for repair.

8: Items for Discussion/Ratification:

> To consider ongoing streetlight maintenance – The cost of £122.29 +vat for repair to the electric supply box on the streetlamp in Norwich Road was proposed by Cllr Ellam, seconded by Cllr Richards and unanimously agreed. A comparison of repair list prices between AMEY and the council's previous supplier was discussed. It was agreed that AMEY would remain the main contractor for repairs while the lamps remain in warrantee, following this period Council will again consider options.

- To discuss removal of the Horse Chestnut tree on the Village Green NCC have advised that they will be removing the Horse Chestnut on the village green, due to decay. If required Council will consider if further replanting is required following its removal.
- > To discuss the Local Government Financial Settlement Consultation No comment required
- Consideration of Christmas events (The meeting was opened to include K Worrell, who updated Council on current fundraising for the Childrens Xmas party, and on Christmas tree lighting on the 2nd December.

Cllr Ellam proposed a donation of £50 towards the Children's Christmas Party, this was seconded by Cllr McDaniel and unanimously agreed and a cheque was raised. This year's party will be held on the 15th December at the Pennoyer Centre; historically the event has catered for between 40 and 60 children.
