TEMPORARY RESTRICTION OF TRAFFIC MOVEMENT

Norfolk County Council, HEREBY GIVE NOTICE that to facilitate the Womens Cycle Tour Event, they intend to make a Traffic Order, the effect of which will be to temporarily restrict vehicular traffic on the:

- 1)** Rolling Road Closures (all full length unless where stated): B1062 Flixton Road, A143 Bungay Road (junction B1062 Flixton Road in a south westerly direction to A143 Harleston Bypass), A143 Harleston Bypass (Roundabout); C571 Redenhall Road/The Thoroughfare/London Road (junction C571 The Thoroughfare to junction C205 Wilderness Lane), C205 Wilderness Lane, C877 Starston Road/The Street/Pulham Road/Harleston Road/The Street/Norwich Road/Harleston Road/The Green/Bank Street/Tattlepot Road/Tivetshall Road, A140 Ipswich Road Roundabout; B1134 Station Road/Long Row/Heath Road, B1077 Mile Road//Haugh Road/New Buckenham Road/Cake Street/The Green/Attleborough Road/Buckenham Road/Station Road/Connaught Road/Exchange Street/Church Street/Norwich Road (from a point 155m north of junction B1077 Connaught Road in a northerly direction for a distance of 30m to a point 185m north of junction B1077 Connaught Road), C139 Besthorpe Road/Bunwell Road/Besthorpe Road/Mile Road/Bunwell Street, B1113 The Turnpike (junction C139 Bunwell Street in a north-easterly direction to B1113 Norwich Road)/Norwich Road/The Turnpike/Norwich Road/The Street, C194 Cuckoofield Lane Roundabout, B1113 Norwich Road/Main Road/Mulbarton Road, A140 Ipswich Road (junction B1113 Mulbarton Road in a northerly direction to junction C820 Hall Road);
- 2)** Temporary Suspension on one-way restriction: A143 Harleston Bypass (Roundabout); C571 The Thoroughfare; C877; A140 Ipswich Road Roundabout; C194 Cuckoofield Lane Roundabout;
- 3)** Temporary suspension of parking and creation of temporary urban clearway: C139 Besthorpe Road (junction of B1077 Norwich Road in an easterly direction to junction U33176 Thieves Lane) in the Town of Attleborough; and
- 4)** C571 The Thoroughfare in the Town of Redenhall with Harleston.

The Order comes into effect from 20:00 hrs on 14<sup>th</sup> June 2016 2016 and will remain in force to 14:30 hrs on 15<sup>th</sup> June 2016 during which times:

- (i) vehicles will be prohibited to enter, proceed, wait or park in the roads set out in 1) above;
- (ii) the roads set out in 2) above will be will be temporarily subject to a suspension of the one-way restrictions;

from 11:30 hrs to 14:30 hrs on 15<sup>th</sup> June 2016;

- (iii) vehicles will be prohibited to park or load or unload in roads 3) from 20:00 hrs on 14<sup>th</sup> June 2016 and will remain in force to 14:30 hrs on 15<sup>th</sup> June 2016; and
- (iv) the road 4) will be temporarily restricted except for emergency vehicle and pedestrian access from 11:30 hrs to 13:00 hrs on 15<sup>th</sup> June 2016.

The provisions of existing permanent Traffic Orders will be temporarily suspended WHERE THEY CONFLICT with the provisions of this Order and during the operation of this Order.

Restriction on traffic will be enforced until normal traffic flow can be maintained following the Event.
